Infinity Banking Membership Terms & Conditions

All Infinity Banking Customers shall be bound by the Terms and Conditions herein. In these Terms and Conditions, "Infinity Banking Customer" refers to a sole customer of the bank, or collectively, two or more joint customers of the Bank, who has/have jointly applied for Infinity Banking membership and whose application has been accepted by the Bank.

1. Infinity Banking Privileges

Infinity Banking services shall be governed by the Terms and Conditions applicable to each such service.

a) Infinity Banking Card

The Bank will issue an Infinity Banking card in the name of each Infinity Banking Customer which allows him/her to enjoy the benefits, status and recognition from Infinity Banking and access automated teller machine (ATM) facilities (details of which are stated in the leaflets enclosed herewith).

b) Credit Card

The Bank will offer complimentary Infinity Banking Platinum/Gold credit cards subject to the conditions set by Bank Negara Malaysia on minimum income requirement. In the case of joint customers one of them will be issued the principal card and the others will be issued with supplementary cards. Additional credit cards requested by Infinity Banking Customers will be subject to the Bank's prevailing charges and fees.

2. Termination of Infinity Banking Membership

a) Infinity Banking Customers or in the case of joint Infinity Banking Customers any one of them may terminate their Infinity Banking membership by giving the Bank written notice.

b) All Infinity Banking privileges accorded an Infinity Banking Customer shall be terminated forthwith upon his/her death or bankruptcy. In the case of joint Infinity Customers the Bank may at its sole discretion terminate or continue to accord all Infinity Banking privileges to the surviving Infinity Banking Customers.

c) Infinity Banking membership is extended to the Infinity Banking Customers at the Bank's sole discretion and the Bank may cancel Infinity Banking membership at any time without any obligation to give Infinity Banking Customers any notice or reasons.

3. Maintenance Fee

A monthly maintenance fee of RM80.00 or such other amount ("Fee") shall be imposed by the Bank from time to time at the Bank's sole discretion and such Fee shall be payable by each Infinity Banking Customer at the end of the month in the event that the monthly total deposit balance in the account(s) in the Infinity Banking Customer's name (whether solely or jointly) falls below RM200,000 or such other minimum average balance fixed by the Bank from time to time. The Bank shall be entitled to automatically debit such fee from the Infinity Banking Customer's account(s) when the Fee becomes due and payable. For the avoidance of doubt, where Infinity Banking membership is held jointly by two or more customers, the said Fee shall be payable by each customer in the event that the monthly total deposit in the said account(s) fall below the requisite minimum average balance.

4. Infinity Banking Membership

Infinity Banking membership is subject to a monthly review at the Bank's sole discretion.

5. Change of Address

a) Infinity Banking Customers shall promptly notify the Bank of any changes in address.

b) In addition, Infinity Banking Customers shall also promptly notify the Bank of any change of their current employer and/or office address.

6. Indemnity

Infinity Banking Customers shall fully indemnify the Bank against all cost and expenses (including legal fees on an indemnity basis) incurred by the Bank in enforcing these Terms and Conditions and the recovery of any amounts due to the Bank or incurred by the Bank in any legal proceedings of whatever nature. Where Infinity Banking membership is extended to two or more customers jointly, the joint customers shall be jointly and severally liable for any liabilities incurred herein.

7. Waiver

No forbearance, neglect or waiver by the Bank in the enforcement of any of these Terms and Conditions shall prejudice the bank's right thereafter to strictly enforce the same.

8. Amendment of Terms and Conditions

The Bank may at its sole discretion amend, add to or delete the Terms and Conditions herein by giving notice of such changes by ordinary post to the Infinity Banking Customers at the address last known to the Bank and such notice shall be deemed to have been received by the Infinity Banking Customers in the ordinary course of post or by any other reasonable means as the Bank deems fit. Such changes shall be effective from the date specified in the said notice. If any Infinity Banking Customer does not accept such changes he/she shall promptly give written notice to the Bank to terminate his/her Infinity Banking membership. If the Infinity Banking Customer shall continue to use and enjoy the Infinity Banking privileges and benefits then it shall be deemed that he/she has accepted such changes to the terms and conditions herein.

9. Governing Law

These Terms and Conditions shall be governed by and construed in accordance with Malaysian laws.
